The Stielau Oil Co. Inc. maintains one master account for each customer. To participate in any of The Stielau Oil Co. Inc. special programs your master account must be in good standing. If you participate in our Automatic Delivery program oil will be delivered to your home, Etc. on a automatic basis of projected gallons computed through standard degree day calculations by The Stielau Oil Co., Inc. Your account will be charged based on standard prices in effect on the date of delivery. In order to cancel automatic delivery we must receive written cancellation from you with your account number, name and address clearly printed or typed on your notice. Any such cancellation will be effective two (2) business days after The Stielau Oil Company receipt of such notice. If you wish to sign up for a budget payment plan, service contract, annual oil purchase or price protection plans a separate form must be signed which will become a part of your master account agreement.

All amounts owed for goods and services are due within fifteen (15) days of the date of the Invoice mailed to you. In the event any extended payment plan is agreed to (for equipment installation, service, tank removal, etc.), you will be required to make agreed upon reasonable periodic payments at least once every calendar month. Interest or finance charges will accrue on all outstanding balances at the rate of 1 1/2% per month or 18% per year.

In the event that any checks are returned for insufficient funds or a closed account your The Stielau Oil Co. Inc. account will be charged a \$30.00 return check fee. In the event a customer defaults on this account agreement the Stielau Oil Co. Inc. may resort to legal collection procedures. You agree to be liable for all cost of collection and reasonable attorney's fees as limited by law and the court.
